

CALL FOR GRANT APPLICATIONS (AE2022-0026)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the Plurianual_LA funded by National Funds through FCT - Portuguese Foundation for Science and Technology, I.P., project (reference LA/P/0063/2020

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: COMPUTER SCIENCE

Scientific subarea:

Grant duration: 6 months, starting on 2022-02-18 with the possibility of being renewed for a maximum term of one year, in cases where the grant has been awarded to students who are enrolled in non-award courses, or up to two years, in the cases of students enrolled in a master's degree.

Scientific advisor: João Tiago Paulo

Workplace: INESC TEC, Braga, Portugal

Maintenance stipend: € 835,98, according to the table of monthly maintenance stipend for FCT grants (http://www.fct.pt/apoios/bolsas/valores), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "Payment of Tuition fees to grant holders".

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

This grant aims at taking advantage of the storage space available, on hundreds to thousands of IoT devices, to store large amounts of information. Such capacity is still underutilized today and could bring economic benefits to companies that are operating IoT devices.

However, these devices have reduced storage and processing capacities and are highly prone to failures. Thus, the solution to be developed will have to contemplate and solve the two previous challenges.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- Design of a distributed file system targeted for large-scale environments. Peer-to-peer algorithms will be used in order to ensure a distributed storage system that tolerates ecosystems with a high amount of failures. Development and evaluation of a proof-of-concept prototype. The tasks described in this working plan demand the application and development of concepts and techniques in the area of Software Engineering which are usually introduced in curricular units included in the curricula of the Mestrados Integrados em Engenharia Informática ou de Mestrado em Engenharia Informática studies.



4. REQUIRED PROFILE:

Admission requirements:

BSc Degree in Informatics Engineering Sciences

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

- Knowledge on gossip algorithms. - Experience with C or C ++ programming language.

Minimum requirements:

- Solid knowledge on distributed systems and storage systems.
- Solid knowledge on fault tolerance
- Knowledge on peer-to-peer systems.

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 60%), Scientific Publications (PC, 10%), Experience (EX, 20%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (80%) and EI (20%).

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

6. FORMALISATION OF APPLICATIONS:

Application Documents:

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree dully recognised in Portugal;
 - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution - can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
 - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. - 4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 - The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
- Other supporting documents relevant to the final assessment.



Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

Application period: From 2022-01-20 to 2022-02-02

Submission of applications: the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

7. BINDING LEGISLATION AND REGULATION

The hiring process shall comply with the current legislation regarding the Research Grant Holder Statute, approved by Law no. 40/2004 of August 18, in its current wording, as well as by the Regulations for Grants of INESC TEC and for FCT Grants Regulation in force.
