

## CALL FOR GRANT APPLICATIONS (AE2022-0080)

INESC TEC is now accepting grant applications to award 1 Post Doctoral Research Grant (BIPD) with the reference TRIO funded by CE, project (reference 2021-1-PT01-KA220-ADU-000033817)

### 1. GRANT DESCRIPTION

**Type of grant:** Post Doctoral Research Grant (BIPD)

**General scientific area:** COMPUTER SCIENCE, TECHNOLOGY

**Scientific subarea:**

**Grant duration:** 12 months, starting on 2022-04-01, with the possibility of being renewed until the end of the project.

**Scientific advisor:** Leonel Morgado

**Workplace:** INESC TEC, Porto, Portugal

**Maintenance stipend:** € 1686,00, according to the table of monthly maintenance stipend for FCT grants (<http://www.fct.pt/apoios/bolsas/valores>), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "[Payment of Tuition fees to grant holders](#)".

The grant holder will benefit from health insurance, supported by INESC TEC.

### 2. OBJECTIVES:

- widen the knowledge of the state of the art in the grant's specific scientific area;
- identify and select the appropriate methods for the work programme;
- develop research capacity by applying the selected methods;
- employ critical thinking to evaluate the research process and attained results;
- launch new research initiatives and develop collaboration networks;
- supervise researchers without a doctoral degree

### 3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- update the state of the art on immersive learning;
- associate that state of the art with ongoing activities at HumanISE and the INESC TEC Nucleus at Universidade Aberta on research, innovation, and technology transfer projects;
- develop activities for research and for coordinating research teams, promoting synergies among ongoing projects and connecting their results to the advancement of the state of the art;
- define goals for development of research and development of cooperation networks and launch funding initiatives to attain them;
- write scientific publications of the results and the grant activities report

#### 4. REQUIRED PROFILE:

##### Admission requirements:

Doctoral Degree in educational technology, digital media, web technology or similar

The PhD degree must have been obtained within the three years prior to the date of submission of the application and the research work leading to the award must have been carried out at a host entity other than INESC TEC.

##### Preference factors:

research experience in educational technology;

##### Minimum requirements:

1 published paper on a peer-reviewed journal

- Ability to read, write, and speak English

#### 5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

**Selection criteria and corresponding valuation:** the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 20%), Experience (EX, 20%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (91%) and EI (9%).

**Release of results and prior hearing:** the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

#### 6. FORMALISATION OF APPLICATIONS:

##### Application Documents:

1. Motivation letter;
2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
3. Certificate or diploma degree fully recognised in Portugal;
  - Documents proving the awarding of academic degrees and diplomas, or the according recognition - in cases of academic degrees or diplomas granted by a foreign higher education institution - can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
  - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. 4. Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
5. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

**Application period:** From 2022-03-02 to 2022-03-15

**Submission of applications:** the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

## 7. BINDING LEGISLATION AND REGULATION
