

## CALL FOR GRANT APPLICATIONS (AE2022-0176)

INESC TEC is now accepting grant applications to award 1 Research Initiation Grant (BII) within the scope of the INESC TEC LA funded by National Funds through FCT - Portuguese Foundation for Science and Technology, I.P., project (reference UIDB/50014/2020)

### 1. GRANT DESCRIPTION

**Type of grant:** Research Initiation Grant (BII)

**General scientific area:** ENGINEERING

**Scientific subarea:** Computer engineering

**Grant duration:** 5 months 21 days, starting on 2022-07-11.

**Scientific advisor:** André Filipe Garcia

**Workplace:** INESC TEC, Porto, Portugal

**Maintenance stipend:** € 486,12, according to the table of monthly maintenance stipend for FCT grants (<http://www.fct.pt/apoios/bolsas/valores>), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "[Payment of Tuition fees to grant holders](#)".

The grant holder will benefit from health insurance, supported by INESC TEC.

### 2. OBJECTIVES:

- Enlarge knowledge regarding front-end programming languages and frameworks
- Enlarge knowledge regarding blockchain / distributed ledger technologies (DLT)
- Improve existing user interface (UI) of a data market prototype for the energy sector, supported by blockchain technology, developed by INESC TEC.
- Prepare technical report.

### 3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- Introduction to the current user interfaces and expected data-market user interactions
- Contribute to the design and development of specific sections of the current UI
- UX and visual improvements to existing sections of the current UI
- Preparation of a technical report

#### 4. REQUIRED PROFILE:

##### Admission requirements:

Studies in informatics or similar

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

##### Preference factors:

- Experience with React JS framework - Experience with Electron framework and NodeJS - Experience with JavaScript, CSS, SASS and HTML - Experience with version control systems (Git) - Fluency in English (spoken and written)

##### Minimum requirements:

- Knowledge in JavaScript, CSS, SASS and HTML
- Practical projects (e.g., university or professional) with direct application of front-end programming languages
- Excellent capacity to work autonomously or integrated in a team

#### 5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

**Selection criteria and corresponding valuation:** the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 55%), Scientific Publications (PC, 10%), Experience (EX, 25%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (70%) and EI (30%).

**Release of results and prior hearing:** the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

#### 6. FORMALISATION OF APPLICATIONS:

##### Application Documents:

1. Motivation letter;
2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
3. Certificate or diploma degree fully recognised in Portugal;
  - Documents proving the awarding of academic degrees and diplomas, or the according recognition - in cases of academic degrees or diplomas granted by a foreign higher education institution - can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
  - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. 4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
  - The proof of enrollment may be presented just during the grant hiring stage.
5. Signed declaration stating not having benefited from any other research fellowship (Article 5, no. 5)
6. Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of

the grant.

7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

**Application period:** From 2022-06-08 to 2022-06-23

**Submission of applications:** the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

## 7. BINDING LEGISLATION AND REGULATION
