

## CALL FOR GRANT APPLICATIONS (AE2022-0184)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the Serviço de Apoio ao Licenciamento (SAL) of the INESC TEC.

### 1. GRANT DESCRIPTION

**Type of grant:** Research Grant (BI)

**General scientific area:** ECONOMICS

**Scientific subarea:** Management studies

**Grant duration:** 12 months, starting on 2022-07-25 with the possibility of being renewed for a maximum term of two years, in the cases of students enrolled in a master's degree.

**Scientific advisor:** Daniel Marques Vasconcelos

**Workplace:** INESC TEC, Porto, Portugal

**Maintenance stipend:** € 875,98, according to the table of monthly maintenance stipend for FCT grants (<http://www.fct.pt/apoios/bolsas/valores>), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "[Payment of Tuition fees to grant holders](#)".

The grant holder will benefit from health insurance, supported by INESC TEC.

### 2. OBJECTIVES:

INESC TEC's Technology Licensing Office (SAL) team is looking for a new employee to perform the functions of technology manager - mapping, protecting and valuing the technological results generated at the institute.

INESC TEC develops very different technologies, from cryptographic methods, robotics, medicine, which calls for a dynamic SAL capable of learning quickly.

The valorization of the Intellectual Property generated in the course of the R&D carried out at INESC TEC is a fundamental activity in the institution. In recent years, the institution has consolidated its position as an innovative agent, having increasingly had the opportunity to be part of prestigious international networks such as the TTO Circle and the EEN or the EIT, among others. Innovating and maximizing the social impact of research is part of the institution's DNA.

### 3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

Activities in the field of knowledge management: technological surveillance, freedom-to-operate analysis, incentives, monitoring of strategic research projects, identification, mapping and formalization of new R&D results, market analysis; definition of intellectual property protection strategies, portfolio management and economic valorization of the results and technologies generated at INESC TEC.

Hands-on training is foreseen by the SAL team in all the tasks mentioned above, as well as support and encouragement of training in international entities of reference in the area of Intellectual Property and Technology Transfer such as WIPO, EPO, IPR Helpdesk, ASTP, LES and CEIPI.

#### 4. REQUIRED PROFILE:

##### Admission requirements:

Degree in Economics, Management, Industrial Management Engineering or similar

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

##### Preference factors:

- Quick ability to learn about new topics; - Pro-active attitude - Excellent interpersonal skills - Participation in entrepreneurship and/or technological acceleration programs - Organization and/or participation in professional training and networking events - Training in Intellectual Property

##### Minimum requirements:

Master's student in the area of Economics, Management, Industrial Management Engineering or similar.

#### 5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

**Selection criteria and corresponding valuation:** the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 40%), Scientific Publications (PC, 0%), Experience (EX, 20%) and Motivation Letter (CM, 40%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (20%) and EI (80%).

**Release of results and prior hearing:** the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

#### 6. FORMALISATION OF APPLICATIONS:

##### Application Documents:

1. Motivation letter;
2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
3. Certificate or diploma degree fully recognised in Portugal;
  - Documents proving the awarding of academic degrees and diplomas, or the according recognition - in cases of academic degrees or diplomas granted by a foreign higher education institution - can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
  - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. 4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
  - The proof of enrollment may be presented just during the grant hiring stage.
5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
6. Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

**Application period:** From 2022-06-15 to 2022-06-30

**Submission of applications:** the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

## 7. BINDING LEGISLATION AND REGULATION

The hiring process shall comply with the current legislation regarding the Research Grant Holder Statute, approved by Law no. 40/2004 of August 18, in its current wording, as well as by the Regulations for Grants of INESC TEC and for [FCT Grants Regulation in force](#).
