

CALL FOR GRANT APPLICATIONS (AE2022-0303)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) with the reference ENERSHARE funded by CE, project (reference 101069831)

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: MATHEMATICS, COMPUTER SCIENCE

Scientific subarea: Applied mathematics, Informatics

Grant duration: 12 months, starting on 2022-10-15, with the possibility of being renewed until the end of the project.

Scientific advisor: Carla Silva Gonçalves

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 1144,64, according to the table of monthly maintenance stipend for FCT grants (http://www.fct.pt/apoios/bolsas/valores), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "Payment of Tuition fees to grant holders".

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

The European ENERSHARE project aims to a) define reference architecture for a European Common Data Space, creating the data value chain perspective for the energy sector; b) evolve the interoperability, trust, and value of data; c) combine blockchain technologies with machine learning techniques, and data market algorithms for the development of data-driven energy and cross-sector services. The project has 7 pilots for demonstration, including one pilot in Portugal.

The main objectives of the Fellowship are:

Develop new distributed learning (federated learning) and machine learning techniques applied to energy sector use cases.

Formulate and implement new approaches for data market in the energy sector.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

Adapting the distributed learning method developed by INESC TEC for non-linear regression problems, classification and considering uncertainty.

Develop new algorithmic approaches and use cases for data markets.

Validate the developed methodologies on real data and different use cases.

Dissemination of the work in international journals and/or conferences



4. REQUIRED PROFILE:

Admission requirements:

Previous academic background in applied mathematics, physics, computer science or similar The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

Experience with time series modelling and forecasting Knowledge in machine learning method Knowledge of programming in Python or R

Minimum requirements:

Previous academic background in applied mathematics, physics, computer science or similar

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 20%), Experience (EX, 20%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (70%) and EI (30%).

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

6. FORMALISATION OF APPLICATIONS:

Application Documents:

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree dully recognised in Portugal;
 - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
 - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. - Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
- 7. Other supporting documents relevant to the final assessment.
