

CALL FOR GRANT APPLICATIONS (AE2023-0117)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the NEXUS funded by IAPMEI with reference 53 Co-financed by Component 5 - Capitalization and Business Innovation, integrated in the Resilience Dimension of the Recovery and Resilience Plan within the scope of the Recovery and Resilience Mechanism (MRR) of the European Union (EU), framed in the Next Generation EU, for the period 2021 - 2026.

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: ENGINEERING

Scientific subarea: Electrical engineering

Grant duration: 6 months, starting on 2023-05-01 with the possibility of being renewed for a maximum term of one year, in cases where the grant has been awarded to students who are enrolled in non-award courses, or up to two years, in the cases of students enrolled in a master's degree.

Scientific advisor: Luís Manuel Pessoa

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 930,98, according to the table of monthly maintenance stipend for FCT grants (https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM_2023.pdf), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "Payment of Tuition fees to grant holders".

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

- Specification, design and prototyping of a near-field antenna characterization system;
- Enlarge the knowledge of the state of the art regarding antenna characterization systems;
- Identification and selection of the most adequate optimization methods to address the proposed workplan:
- Develop the research skills through the application of the selected methods;
- Apply the scientific method on the research process and a critical attitude on the obtained results.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- Design and optimize a wideband and dual polarization measurement probe through electromagnetic

simulation, followed by fabrication and experimental characterization in anechoic chamber.

- Design an electronic control system for sequential activation of the measurement probes;
- Create technical drawings of the mechanical components to be manufactured.

- Assemble and integrate the fabricated components together with the specified microwave absorbers, with 3D printed accessories, as well as the motorized rotation stages.

- Perform functional tests for the validation of the developed system.

- Writing of the grant activities report.



4. REQUIRED PROFILE:

Admission requirements:

Enrolment in MSc in Electrical Engineering, or similar.

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

Hands-on experience with antenna characterization systems; Experience with 3D electromagnetic simulation software.

Minimum requirements:

- Experience with the prototyping of parts in a 3D printer, electronics circuits design and step motor control solutions.

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 40%), Scientific Publications (PC, 5%), Experience (EX, 40%) and Motivation Letter (CM, 15%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (65%) and EI (35%).

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

 - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
 - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. - Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
 - Other supporting documents relevant to the final assessment.
