

CALL FOR GRANT APPLICATIONS (AE2023-0131)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the StoneByPortugal funded by IAPMEI with reference 40 Co-financed by Component 5 - Capitalization and Business Innovation, integrated in the Resilience Dimension of the Recovery and Resilience Plan within the scope of the Recovery and Resilience Mechanism (MRR) of the European Union (EU), framed in the Next Generation EU, for the period 2021 - 2026.

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: ENGINEERING

Scientific subarea: Electrical engineering

Grant duration: 6 months, starting on 2023-05-01 with the possibility of being renewed for a maximum term of one year, in cases where the grant has been awarded to students who are enrolled in non-award courses, or up to two years, in the cases of students enrolled in a master's degree.

Scientific advisor: Ana Cristina Pires

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 930,98, according to the table of monthly maintenance stipend for FCT grants (https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM_2023.pdf), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "Payment of Tuition fees to grant holders".

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

The Sustainable Stone by Portugal project under the PRR will address the enhancement of Natural Stone for a digital, sustainable and qualified future. The project, in general, aims to develop and implement a new specialization ecosystem that allows the effective valorization of technological knowledge. Within the scope of the activity related to Innovative Stone CHAINSAW, the objective will be to develop a conceptual solution and a proof of concept to solve the problem of this action. The proposed conceptual solution will contribute to the sensory area and optimization of the saw cutting machine.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- Conduct a survey of requirements for the development of solutions in order to optimize the saw cutting process in underwater environments;

- Presentation of a conceptual model, which may include several solutions, in order to contribute to the sensory area and optimization of the saw cutting machine in order to reduce the thickness of the cut (increasing the profitability of cutting and speed);

- Contribution to the search for encapsulation and maritimization solutions for some components of the saw cutting machine (battery) in order to work in an underwater environment;

- Exercise a critical spirit in evaluating the research process and the results obtained.

4. REQUIRED PROFILE:

Admission requirements:

Degree in electrical engineering, mechanics or related field.

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

Prior experience in the sensory area, deep learning, geo-technologies, vision, data processing, and domain of SOLIDWORKS and other software will also be valued. Previous knowledge in using the ROS framework.

Minimum requirements:

Degree in Electrical Engineering.

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 30%), Scientific Publications (PC, 10%), Experience (EX, 30%) and Motivation Letter (CM, 30%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (80%) and EI (20%).

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

6. FORMALISATION OF APPLICATIONS:

Application Documents:

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree dully recognised in Portugal;
 - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
 - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. - Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
- 7. Other supporting documents relevant to the final assessment.
