

# CALL FOR GRANT APPLICATIONS (AE2023-0213)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) on the scope INNOAQUA with reference 101084383 funded by the European Commission under the Horizon Europe program for the period 2021-2027.

## **1. GRANT DESCRIPTION**

Type of grant: Research Grant (BI)

### General scientific area: ENGINEERING

Scientific subarea: Computer engineering

**Grant duration:** 12 months, starting on 2023-09-04 with the possibility of being renewed for a maximum term of two years, in the cases of students enrolled in a master's degree.

Scientific advisor: Filipe David Ferreira

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 930,98, according to the table of monthly maintenance stipend for FCT grants , paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "Payment of Tuition fees to grant holders".

The grant holder will benefit from health insurance, supported by INESC TEC.

## 2. OBJECTIVES:

To broaden the knowledge of the state of the art in the specific scientific area of the fellowship;

To develop a platform for data acquisition and processing for sustainability and decarbonisation. This platform aims at collecting and propagating data, for sustainability and decarbonisation, along the seaweed production value chain.

To exercise critical thinking in the evaluation of the research process and the results obtained.

## 3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

Investigate and develop platform for integration of information systems with production systems (IIoT); Survey of requirements of the platform;

Specification and architecture of the platform;

Implement the platform in a laboratory environment, using automation and control technologies, as well as technologies for integration of information systems with automation systems;

Testing and validation;

To publish results of the research and development activities in conferences and/or scientific journals; To write the report of the grant activities.



### 4. REQUIRED PROFILE:

#### Admission requirements:

Undergraduate or Master's student in Computer Engineering or a related field.

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

### **Preference factors:**

Knowledge of programming automation systems; Knowledge of nodered, grafana, timesacleDB, Kafka technologies; Knowledge of OPC-UA; Experience in using Spring eco-system, namely Spring Framework, Spring Boot, Spring Data and Spring Cloud. Experience in the use of graphical interface development frameworks Vue.js Strong capacity for teamwork; Knowledge of English and Portuguese.

### Minimum requirements:

Experience in software development using Java (Backend) and/or JavaScript+CSS (Frontend).

## 5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

**Selection criteria and corresponding valuation:** the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 10%), Experience (EX, 30%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (80%) and EI (20%).

**Release of results and prior hearing:** the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

## 6. FORMALISATION OF APPLICATIONS:

## **Application Documents:**

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree dully recognised in Portugal;
  - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
  - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. - Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
  The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
