Project overview: The work to be developed consists of providing legal support to a research institution, by applying the national, European and international legal framework for research institutions to the organisation in all its aspects, from institutional to contractual activity. This support will include the preparation of contractual drafts, definition and negotiation of contractual conditions, monitoring of relations with external entities (e.g. Courts, Funding Bodies and Auditors) in order to ensure compliance with the institution's legal obligations, as well as the preparation of internal legal opinions. The work will involve the permanent need to update knowledge in order to guarantee the best and most appropriate legal framework.

Objectives: Support for the institution in its day-to-day activity, namely in negotiating contractual terms with national and international entities subject to different legal regimes, in solving institutional problems of a civil/commercial nature, such as participation in companies and other entities, or incorporation of companies, as well as legal support in the scope of R&D projects and funded, national and international projects and dispute prevention. Given the nature of the institution and its legal framework, you should be prepared to answer basic questions of Public Law, ensuring a good articulation between both fields, in addition to the analysis, synthesis and preparation of opinions/documentation related to the activities of the institution.
