

CALL FOR GRANT APPLICATIONS (AE2024-0022)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) smartDBS funded by Santa Casa, project (reference MB-12-2022)

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: COMPUTER SCIENCE

Scientific subarea: Computer Systems

Area of Work: Web and mobile systems in the field of Biomedical engineering for monitoring using Wearables

Grant duration: 3 months, starting on 2024-03-01, with the possibility of being renewed until the end of the project.

Scientific advisor: Duarte Filipe Dias

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 930,98, [according to the table of monthly maintenance stipend for FCT grants](#), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the [Regulations for Grants of INESC TEC](#) and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "[Payment of Tuition fees to grant holders](#)".

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

Development of web and mobile applications for monitoring and tracking people/patients using wearable devices. These systems have been used by Hospitals (CHUSJ) and by companies in different industrial areas. The application aims to expand the use of web and mobile systems that the Engineering Center has been developing to support data collection.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

Familiarization, development, improvement and validation with end users of e-health systems, consisting of a mobile application (Android Studio and Flutter framework), a web component and the respective back-end associated with a database (PHP, SQLite, Flutter Web). Improving systems and validating them in real scenarios, as well as preparing presentations related to them.

4. REQUIRED PROFILE:

Admission requirements:

The candidate must be Master's student in the field of Biomedical Engineering, Computer Engineering, Software Engineering or equivalent,

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

Experience in developing applications in Flutter and deploying them on Android and iOS through distribution tools. Previous experience in clinical studies with m-health systems.

Minimum requirements:

Good knowledge and some experience in developing mobile and web applications. The candidate should already have prior knowledge of Google's firebase system, Android Studio and Flutter, as well as PHP bases and code version control systems (GitHub, GitLab)

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the [Regulations for Grants of INESC TEC](#), while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 35%), Scientific Publications (PC, 15%), Experience (EX, 30%) and Motivation Letter (CM, 20%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (60%) and EI (40%).

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

6. FORMALISATION OF APPLICATIONS:

Application Documents:

1. Motivation letter;
2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
3. Certificate or diploma degree;
4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 - The proof of enrollment may be presented just during the grant hiring stage.
5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
6. Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

Application period: From 2024-01-25 to 2024-02-07

Submission of applications: the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

7. BINDING LEGISLATION AND REGULATION

The hiring process shall comply with the current legislation regarding the Research Grant Holder Statute, approved by Law no. 40/2004 of August 18, in its current wording, as well as by the [Regulations for Grants of INESC TEC](#) and for [FCT Grants Regulation in force](#).
