

CALL FOR GRANT APPLICATIONS (AE2025-0316)

INESC TEC is now accepting grant applications to award 2 Research Grant (BI) within the scope of the Multiannual Funding of R&D Units 2025-2029, with the reference UID/50014/2023, Funded by national funds through the Portuguese Foundation for Science and Technology (FCT), I.P.

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: ENGINEERING

Scientific subarea: Electrical engineering

Area of Work: Robotics

Grant duration: 12 months, starting on 2025-09-01 with the possibility of being renewed for a maximum term of two years, in the cases of students enrolled in a master's degree.

Scientific advisor: José Miguel Almeida

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 1040.98, [according to the table of monthly maintenance stipend for FCT grants](#), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the [Regulations for Grants of INESC TEC](#) and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "[Payment of Tuition fees to grant holders](#)".

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

- Prepare a state-of-the-art review on the use of sensors for complex robotic systems in the field of maritime robotics;
- Contribute to the processing of data collected by sensors or sensor networks for autonomous vehicles by producing appropriate hardware and software;
- Design and develop an underwater electrical cable simulator;
- Write the grant's activity report.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- Expand knowledge of the state of the art in the specific scientific area of the grant;
- Identify and select appropriate methods for the study in question;
- Develop research capabilities through the application of selected methods;
- Work in multidisciplinary teams;
- Exercise critical thinking when evaluating the research process and the results obtained.

4. REQUIRED PROFILE:

Admission requirements:

Master's student in Electrical Engineering or related field

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

- Knowledge of mobile robotics, electronics design, and ease of use of Matlab and Python in the scientific field;
- Fluency in English (written and spoken);
- Good communication, planning, time management, and risk management skills, as well as experience writing technical and scientific reports.

Minimum requirements:

- Master's student in Electrical Engineering or related field
- The scholarship award assumes that the applicant is a student in a course of study or a non-degree-granting course taught at a Higher Education Institution.
- Experience programming in C and C++;
- Experience in Linux and ROS 1/2;
- Experience operating autonomous robots in a maritime environment;
- Successful completion of the Basic Maritime Safety Course.

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the [Regulations for Grants of INESC TEC](#), while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 0%), Experience (EX, 35%) and Motivation Letter (CM, 15%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (80%) and EI (20%).

DISABILITY INCENTIVE

Candidates who present a degree of disability equal to or greater than 90% will benefit from an incentive (20) in the score of the CV Assessment.

Candidates who present a degree of disability equal to or greater than 60% and less than 90% will also benefit from an incentive (10) in the score of the CV Assessment.

Said score may, in these cases, exceed 100 points.

Candidates must demonstrate the degree of disability during the application, namely through the submission of the Multi-Purpose Medical Certificate of Disability, issued in accordance with Decree-Law no. 202/96, of October 23 - currently in effect.

Candidates must declare, in the application form, the type of disability used throughout the selection process, in order to proceed with the required adaptations.

1. Motivation letter;
2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
3. Certificate or diploma degree;
4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 - The proof of enrollment may be presented just during the grant hiring stage.
5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
6. Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

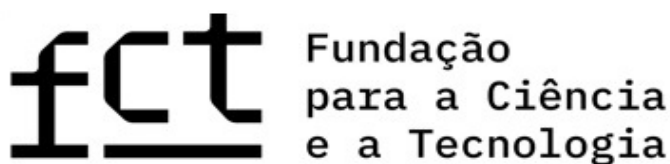
