

CALL FOR GRANT APPLICATIONS (AE2025-0408)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the ATE funded by IAPMEI with reference 56 Co-financed by Component 5 - Capitalization and Business Innovation, integrated in the Resilience Dimension of the Recovery and Resilience Plan within the scope of the Recovery and Resilience Mechanism (MRR) of the European Union (EU), framed in the Next Generation EU, for the period 2021 - 2026.

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: ENGINEERING, COMPUTER SCIENCE, MATHEMATICS

Scientific subarea:

Area of Work: Energy Management

Grant duration: 8 months 21 days, starting on 2025-10-10.

Scientific advisor: Alexandre Lucas

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 1040.98, [according to the table of monthly maintenance stipend for FCT grants](#), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the [Regulations for Grants of INESC TEC](#) and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "[Payment of Tuition fees to grant holders](#)".

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

The overall vision of the ATE is to deploy and demonstrate a set of business models leveraging on AI and optimization, applying data science and analytics techniques. Such tools will support the integration of Distributed Energy Storage (DES) and Distributed Energy Resources (DER) in Renewable Energy Communities, to enable the hybridization, utilisation and monetisation of storage flexibility, within a real-life environment. The project outcome will allow various DES, DER and several new generation Energy Management Systems (EMS) to be integrated by different stakeholders, while demonstrating the value added of asset's connection to common data space, reducing uncertainty and hence increasing acceptance by technology takers and final users.

The main objectives of the Fellowship are:

- 1) Apply data analysis and identify energy management use cases in renewable energy communities and industry.
- 2) Perform predictions, create baselines and develop AI services (including generative AI and Foundational Models) applied to Energy consumption in the domestic and industrial segment.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- 1) Development of workflows and algorithms to complement datasets of connected data spaces, to improve analysis results (forecasting, analysis of financial tools, predictive maintenance and optimization of the operation)

- 2) Conducting analysis on models related to energy storage and developing prediction models to show, against a baseline, the improvement of the evaluated tools by integrating third-party data (from connected data spaces or other federated digital learning platforms).
- 3) Validate the developed methodologies on real data and real demonstration sites, in particular the existing use cases that are part of the ATE project using the developed AI tools, optimization and energy efficiency models (including Gen AI).
- 4) Dissemination of the work in international journals and/or conferences

4. REQUIRED PROFILE:

Admission requirements:

Academic background in data science, engineering, computer science, mathematics, informatics or similar. The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

- Past experience (or academic training) with energy data analysis and optimization
- Experience with simulation techniques, energy efficiency models, large-scale energy consumption data, machine learning techniques and interpretation (unsupervised)
- Education, experience and research orientation

Minimum requirements:

- Programming knowledge in Python/others
- Fluent in English

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the [Regulations for Grants of INESC TEC](#), while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 20%), Experience (EX, 20%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (70%) and EI (30%).

DISABILITY INCENTIVE

Candidates who present a degree of disability equal to or greater than 90% will benefit from an incentive (20) in the score of the CV Assessment.

Candidates who present a degree of disability equal to or greater than 60% and less than 90% will also benefit from an incentive (10) in the score of the CV Assessment.

Said score may, in these cases, exceed 100 points.

Candidates must demonstrate the degree of disability during the application, namely through the submission of the Multi-Purpose Medical Certificate of Disability, issued in accordance with Decree-Law no. 202/96, of October 23 - currently in effect.

Candidates must declare, in the application form, the type of disability used throughout the selection process, in order to proceed with the required adaptations.

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

6. FORMALISATION OF APPLICATIONS:

Application Documents:

1. Motivation letter;
2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
3. Certificate or diploma degree;
4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 - The proof of enrollment may be presented just during the grant hiring stage.
5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
6. Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

Application period: From 2025-09-05 to 2025-09-18

Submission of applications: the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

7. BINDING LEGISLATION AND REGULATION

The hiring process shall comply with the current legislation regarding the Research Grant Holder Statute, approved by Law no. 40/2004 of August 18, in its current wording, as well as by the [Regulations for Grants of INESC TEC](#) and for [FCT Grants Regulation in force](#).
