

CALL FOR GRANT APPLICATIONS

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the within the scope of the project WaveSense with reference 17176 (COMPETE2030-FEDER-00865400) co-funded by the ERDF - European Regional Development Fund through Innovation and Digital Transition Program - COMPETE 2030 under the scope of Portugal 2030 and by National Funds through the FCT - Fundacao para a Ciencia e a Tecnologia, I.P. (Portuguese Foundation for Science and Technology).

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: ENVIRONMENTAL SCIENCE, TECHNOLOGY

Scientific subarea: Environmental technology, Instrumentation technology, Optronics, Micro-technology, Nanotechnology

Area of Work: Development of photonic crystal-based sensors for water contaminants sensing.

Grant duration: 6 months, starting on 2026-07-01, with the possibility of being renewed until the end of the project.

Scientific advisor: Luís Carlos Coelho

Workplace: FCUP - Faculdade de Ciências da Universidade do Porto

Maintenance stipend: € 1359.64, [according to the table of monthly maintenance stipend for FCT grants](#), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the [Regulations for Grants of INESC TEC](#) and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

Experimental demonstration and optimization of different PhC structures; characterization of the fabricated structures with different surrounding media; development of prototypes for the characterization of optical sensors on top of planar substrates and on optical fibres: develop integrated systems with software for control, acquisition, and data analysis: apply the detection systems developed in a real context.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

The WaveSense project aims to develop artificially structured materials to generate and control electromagnetic surface waves (ESW), commonly referred to as metamaterials, for sensing chemical, biochemical, and biological substances in water streams. The candidate should investigate new methodologies for the development of a photonic crystal (PhC) architecture to be applied for the monitoring of small water contaminants.

4. REQUIRED PROFILE:

Admission requirements:

Master's degree in engineering physics.

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

Experience in work with optical systems and in developing prototypes, including electronic systems; advanced knowledge in 3D design and prototyping through 3D printing.

Minimum requirements:

Master's degree in engineering physics; knowledge of optoelectronic systems; proven experience in fiber optic engineering; experience in the anodization of aluminium surfaces; experience in microcontroller programming and software development for analysis and control.

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the [Regulations for Grants of INESC TEC](#), while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 40%), Scientific Publications (PC, 20%), Experience (EX, 20%) and Motivation Letter (CM, 20%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (70%) and EI (30%).

DISABILITY INCENTIVE

Candidates who present a degree of disability equal to or greater than 90% will benefit from an incentive (20) in the score of the CV Assessment.

Candidates who present a degree of disability equal to or greater than 60% and less than 90% will also benefit from an incentive (10) in the score of the CV Assessment.

Said score may, in these cases, exceed 100 points.

Candidates must demonstrate the degree of disability during the application, namely through the submission of the Multi-Purpose Medical Certificate of Disability, issued in accordance with Decree-Law no. 202/96, of October 23 currently in effect.

Candidates must declare, in the application form, the type of disability used throughout the selection process, in order to proceed with the required adaptations.

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

6. FORMALISATION OF APPLICATIONS:

Application Documents:

1. Motivation letter;
2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
3. Certificate or diploma degree;

4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 - The proof of enrollment may be presented just during the grant hiring stage.
5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
6. Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

Submission of applications: the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

7. BINDING LEGISLATION AND REGULATION
